NJLBA GRANT FROM THE DEPARTMENT OF LABOR

The NJLBA has applied for and received a grant from the Department of Labor to conduct free training programs for our members. The programs that we have been approved for are Techniques of Alcohol Management (TAM), ServSafe, ServSafe Recertification, Social Networking to Enhance your Retail Business and New Business/Compliance Training.

The grant terms runs from November 4, 2011 through November 4, 2012. The courses will be offered on a first come basis until the grant funds are expended. The only requirement of the licensee is that you must pay your employees to attend the training and supply your Tax Id number to our office. However, you must be cleared by the Division of Taxation where they will check for tax clearance. If you are not cleared by Taxation you can not attend the class until you are. We must have your tax id number our office at least 5 days prior to the training date. *You no longer will need to complete the cumbersome financial form previously sent to as this has now been waived by Labor.* If you plan on taking any class at any time please contact the NJLBA so that we may put you in our data base and in the event you want to attend a future training. In addition, if anyone is interested in hosting training at your location please contact Anastasia at anastasianjlba@aol.com. As training dates and locations become available they will be posted on our website at www.njlba.org. Please call at 609- 394-6730 should you have any questions or require any further information. This is an excellent opportunity to get your training requirements up to date and protect your business. Classes currently being offered are:

Techniquues of Alcohol Management (TAM) – 3 Hours

The course is structured to offer a variety of problemsolving techniques as they relate to businesses selling beverage alcohol for consumption on and off licensed premises. A TAM trained alcohol server is one who has learned to balance the responsible sale of beverage alcohol with the day-to-day service of his/her customers.

As a TAM participant you receive: comprehensive, pro-

fessionally administered seminar, work book to take home, personalized certification card for everyone obtaining a passing grade on the final test, official TAM certificate for participating establishments, and possible discount on insurance offered by certain companies.

ServSafe – 12 Hours and ServSafe Recertification – 8 Hours

New Jersey retail food rules (chapter 24, Sanitation in Retail Food Establishments and Food and Beverage Vending Machines) requires that if a food establishment is classified as a "Risk type 3 food establishments" there must be at least one certified food protection manager on site who is responsible for food safety operations. Through the ServSafe training program, food managers will become knowledgeable of the latest FDA Food Code and New Jersey's food safety regulations. This comprehensive course will cover all of the required elements of safe food handling. The course will cover origins of food contamination, personal hygiene and overall employee involvement in safe food handling. Upon successful completion of the course, the managers will obtain food safety certification that is valid for three years. For those managers that have already taken the ServSafe class but need to be recertified we also have the ServSafe Recertification class available. Servsafe is also offered in Spanish.

Social Networking to Enhance Retail Businesses – 3 Hours

Aims to educate the business owner and/or selected employees on how to capitalize on the use of technology to increase their business. In many instances, social networking technologies such as Facebook, Twitter, Groupon and texting are becoming the social norm for driving incremental businesses, especially for small businesses. This type of technology is replacing costly media advertising such as radio, print, etc. and can offer a fairly inexpensive means of communicating with the public. Various uses of technology

Legislative Affairs Report

News from Trenton- Attacks on Hospitality Sector Continue

For New Jersey's hospitality sector, 2011 was one of the toughest years on record since Prohibition. An overstatement? Unfortunately, it is accurate. January 9, 2012 witnessed the end of New Jersey's 214th Legislative Session and, not coincidentally, it also was the day that the Legislature passed and sent S2782 (Sweeney) to Governor Christie for his signature – the bill that permits wineries to direct ship to both retailers and to consumers. In the bigger picture, the direct shipment bill will cause significant long-term harm to New Jersey's highly efficient three-tier system of beverage alcohol distribution. Along with this harm to our industry piggybacks the attendant loss of tax revenue to the State of New Jersey. The Excise Taxes on all out-of-state wine shipped via the Internet will now remain - legally with the state of origin (California mostly) and the Sales Tax collections, which due to a pronounced lack of enforcement is virtually voluntary, will also suffer.

With the 215th Legislature now sworn in, our beleaguered hospitality sector - already suffering from a historically weak economy where entertainment dollars are in short supply - face a disturbing gauntlet of further damaging legislation including, but not limited to, the following:

- > Establishment of new Beer and Wine on-premise consump-
- > Elimination of the "Two License Limit" on distribution licenses
- > Creation of a new Limited Religious Retail Distribution License – permitting kosher grocers to have full package store privileges through the issuance of new licenses to costs between \$31-\$61!!! No cap on numbers to be issued!!!
- > Permitting towns and license holders to move pocket licenses from any town to any other town in New Jersey with simple governing body resolutions. Can be moved even if town is already over the population cap and even if licenses are readily available.

This is merely a small sampling of a host of very problematic legislation pending and seeing activity in Trenton. We need full NJLBA involvement to be successful.

On the Division of Alcoholic Beverage Control front, this month we bid farewell to Director Jerry Fischer after successfully completing an impressive, record-setting twelve-year tenure at the helm. Director Fischer has returned to the Attorney General's Office as an Assistant Attorney General managing complex litigation. Director Fischer's sage intelligence, intellectual curiosity, easy manner and open door policy set the tone for better than a decade's worth of deft management of a most difficult industry. Director Fischer will be missed. For those of you who would like to join the "Bon Voyage" to

Be prepared on short notice to come to Trenton on a Monday or a Thursday to make sure that your voice is heard as the legislative process proceeds.

President Obama enacted the Patient Protection and Affordable Care Act (PPACA) on March 23, 2010. There are many parts of the bill that have already gone into effect and will continue with timelines extending beyond tax years beginning after December 31, 2017. We have reached out to Gary V. Cupo, ChFC, President/CEO of Benefit Solutions (a health insurance wholesaler) to provide information to our members that will help you through the many changes that will occur concerning your individual and group health insurance needs. I would like to thank Diane Weiss and members of the board for this opportunity to be of service to you. Since the enactment of PPACA, there have been many parts of the bill that have already gone into effect. Below are a few of the most notable changes affecting your health insurance coverage for fully-insured and self-insured group and individual health plans:

- Plans are prohibited from having lifetime limits on the dollar value of benefits for any participant or beneficiary.
- Coverage of specific preventive services with no cost sharing of deductible and copays by the insured. This will affect many screening tests, such as mammography, colonoscopy and routine physical exams.
- Plans must now increase the age of a dependent to age 26. Dependents can be married. New Jersey has enacted certain plans to cover dependents to the age of 31.
- Plans will have to cover preexisting conditions for children 19 and under.

Many states have considered the individual mandates to this new law to be considered unconstitutional. At the end of June 2012, the Supreme Court will rule on its final outcome. With the upcoming Presidential election, it is unclear if parts of the bill or the entire bill will be overturned. However, everyone must move forward assuming there are no changes to come.

The law requires individual and group health insurance exchanges to be offered by each state. If the state waves their rights to offer a State Exchange, that state will become part of a Federal Exchange. A catastrophic-only policy

would be available for those 30 and younger. In addition the states must create "Exchanges" to help small employers to purchase coverage. Coverage in the Exchange will only be offered on a pre-tax basis if it is purchased through an employer.

An employer does not have to offer coverage, but if they do not offer qualified coverage and employ more than 50 full-time equivalent employees (with an exception for seasonal workers) and one or more employees received a premium assistance tax credit to buy coverage through an exchange, the employer must pay a fine of \$2,000 per year times the number of full-time equivalent employees. An individual with family income up to 400% of (Federal poverty level) is eligible for a premium assistance tax credit if the actuarial value of the employer's coverage is less than 60% or the employer require the employee to contribute more than 9.5% of the employee's family income toward the cost of coverage.

Does anyone really expect the consumer to understand this maze of confusion? At first, the government expected the consumer to deal with "Navigators" that were not licensed in the field of health insurance. Through the efforts of NAHU (National Association of Health Underwriters), we were successful in lobbying that these "Navigators" can be licensed experienced health insurance professionals.

Wellhofer Scholarship

William G. Wellhofer of Atlantic City was one of the founders of the New Jersey Tavern Association, which later became the United Tavern Owner's Association of New Jersey which we now operate under the name of the New Jersey Licensed Beverage Association. In 1944, it was decided that a memorial be established in the memory of Mr. William Wellhofer for his foresight and drive in founding the association and ideals of the on-premise licensees in the State of New Jersey. Because Mr. Wellhofer was a college graduate and believed in higher education, it was decided to form the William G. Wellhofer Scholarship Foundation.

The Robert Wilinski Scholarship was established in 1991 as a lasting memorial to the late Robert Wilinski, who passed away in April of that year. Mr. Wilinski was an attorney and friend who represented the NJLBA for over thirty years. Mr. Wilinski joined the William T. Cahill law firm in 1951, later to become senior partner.bHe began attending NJLBA board meetings in the absence of the NJLBA's chief counsel, William T. Cahill, when he was elected to Congress in 1958.

The newly created scholarship was made part of the existing William G. Wellhofer Scholarship Foundation and was renamed the Wellhofer/Wilinski Scholarship Foundation. New guidelines were established as criterion for awarding the scholarship. The scholarships are reserved for the sons, daughters and grandchildren of present dues paying members of the New Jersey Licensed Beverage Association and the sons, daughters and grandchildren of retired members who had paid their dues for at least five full years prior to their retirement.

Though there are limited guidelines, the applications are scored on a point system that includes the high school cumulative grade average, rank in class, activities and counselor's recommendations. The winners are selected from an anonymous list presented to the Wellhofer/Wilinski Committee. The two scholarships awarded annually are in the amount of \$10,000, \$2,500 per year, and is offered to a matriculated, full time undergraduate student attending any recognized degree granting university in the United States. Scholarship applications are due April 30th, 2012 and should be sent to the NJLBA office in Trenton. Contact the Association at 609-394-6730 for an application. The grant recipients will be notified in writing and the winners will also be announced at the Wellhofer/Wilinski Scholarship Picnic in June. The Wellhofer/Wilinski Scholarship picnic will be held this year on Wednesday June 27th from 2 PM to 7 PM at the Oak Tree Lodge, 1412 Schoolhouse Road, Wall Township, NJ. We look forward to seeing you all at the picnic again this year.

JOE ARDIRE'S CORNER


